

Refund Policy

Any person wishing to withdraw from the tour and be issued be issued with a refund must confirm their withdrawal from the tour in writing to Immersive Education. All deposits are non-refundable.

Cancellation costs are as follows for all travellers:

- More than 120 days prior to departure 80% refund of total tour cost;
- 90-120 days prior to departure 60% refund of total tour cost;
- 60-89 days prior to departure 40% refund of total tour cost;
- Less than 60 days prior to departure No refunds

Please note there may be specialised inclusions in your tour such as sporting event tickets, instant purchase airline tickets, meal vouchers and attraction entry tickets that are non-refundable in addition to the above cancellation charges. These cancellation fees are in addition to any cancellation fees that may be levied by our tour suppliers.

IMPORTANT INFORMATION

Please read the following booking conditions carefully and ensure that all tour participants are made aware. All costs shown are subject to change, due to exchange rate fluctuations and increases in land and/or air costs which arise between now and the date of departure.

Tour Prices: Tour prices are based on costs as of January 1 in the year which the quote was issued. Costs will also depend on availability of hotels quoted on at time of acceptance of the quote. These costs are subject to the group travelling together throughout the tour. Any variation may incur fees and may also jeopardize the costs for the rest of the group. Prices are based on the tour numbers stipulated in the tour quote. Any change in tour numbers will result in a revised tour price. Costing is based on an average exchange rate being not less than 1 AUD = 0.70 USD. Fluctuations in exchange rate below 0.70 USD may result in additional tour charges that will be charged to individuals as an additional cost. Any of these charges imposed by the exchange rate deficit will be notified to you at the earliest possible time, the latest at which will be 45 days prior to departure.

Documentation: Australian citizens require a passport with minimum 6 months validity from date of departure from destination. Other passport holders may require additional documentation. Please check your applicable requirements with the United States Embassy.

Baggage: Free baggage allowance one piece weighing maximum 23kg / 50lb plus one cabin bag please note these restrictions vary between airlines and depends on your destination. Luggage in excess of these limits will be charged for at the appropriate excess baggage rates. Baggage is the responsibility of the passenger at all times.

Airline and Airport Taxes, Surcharges & Levies: Are included in the tour cost, however these do continually change and if these cost rise above \$250.00 per person this amount will be charged to individuals as an additional cost. Any of these charges imposed by the airline will be notified to you at the earliest possible time, the latest at which will be 45 days prior to departure.
